DIRECTIVE TO ALL PARTIES & LEGAL REPRESENTATIVES:

- 1. Matters will be heard in <u>virtually by way of video conferencing</u> on MS Teams on the dates allocated on the roll, subject to such reallocations as may become necessary.
- 2. Parties must forthwith inform the judge's secretary of all settlements, postponements & removals to facilitate possible reallocations. Parties will be informed of any reallocations. - 6. By no later than <u>14h00 on Friday 12 March 2021</u> all parties must forward draft orders in Word format to the judge's secretary which reflect the relief sought by each such party.
